

# Lighthouse Point "Tender" Community Bus Route and Timetable

The City of Lighthouse Point Community Bus "Tender" is air-conditioned, wheelchair accessible in accordance with the American Disabilities Act (ADA), and free of charge.

This service is designed to work in conjunction with Broward County Transit (BCT) by way of connection to BCT fixed routes, 10, 11, 34, 83 and US 1 Breeze. Riders making connection with BCT buses are expected to pay the appropriate fares.

Other community bus routes connecting with the "Tender" are as follows:

\*City of Pompano Beach and Hillsboro Beach at Pompano Citi Centre, Timepoint #11

\*City of Deerfield Beach and Hillsboro Beach at Target, Timepoint #12

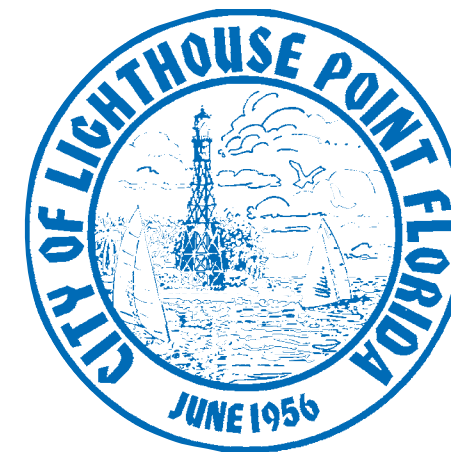

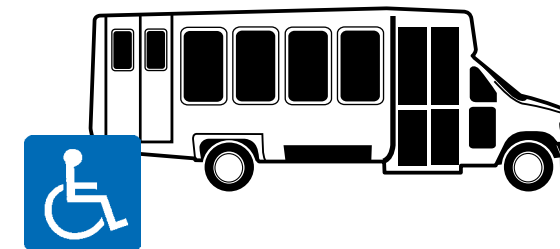
